



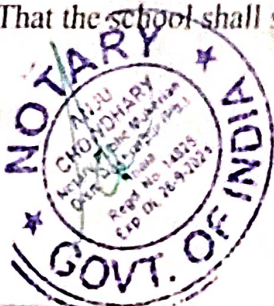
AFFIDAVIT



5. That school is not paying any charges towards using name, motto, logo or any other non academic activities to any other institution, organization or body.
6. That the school will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.
7. That the Principle and Correspondent/Manager of the school have individually gone through the provisions contained in the affiliation & examination bye-laws and the circulars issued by the Board from time to time. The school undertakes to abide by the provisions contained in the affiliation & examination bye-laws, directions issued from time to time and the law of the land.
8. That the school will ensure compliance of all statutory requirements like EPF,ESI, and Labour Laws etc. with respect to the school and staff of the school.
9. That the school will ensure that the Building Safety, Fire Safety, Water Safety, Health and Hygiene Certificates are being issued or renewed by the concerned Municipal or State authorities from time to time as per prescribe term.
10. That the school will ensure that the required in infrastructure is available with the school before starting classes.
11. That the school will ensure that sufficient number of qualified teachers as per the provisions contained in affiliation bye-laws are available in the school before starting classes.
12. That the school will follow the provisions related to fee contained in affiliation bye-laws and will disclose the details of the fee to the student/ parents every year before start of session without restoring to any hidden charges in the heads of the fee.
13. That the school will not coerce any student/parents to buy book/stationery/uniform from any particular shop.
